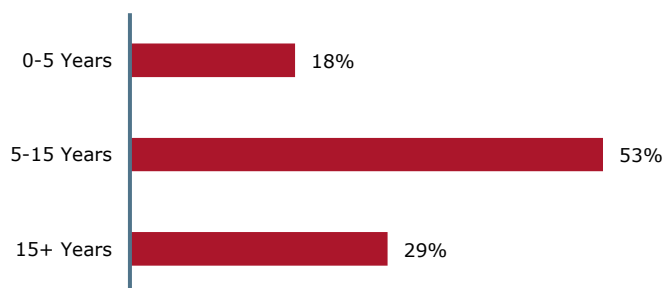
Market Commentary

INTEREST RATES - The Monetary Policy Committee (MPC) maintained the Central Bank Rate (CBR) at **8.75%** in June, citing well-anchored inflation expectations, with inflation remaining within the target range of **2.5%–7.5%**, alongside a stable exchange rate. The decision was also intended to support private sector credit growth, which accelerated to **9.3%** in May from **7.1%** in April. Meanwhile, yields on short-term government securities rose during the month, led by the **182-day Treasury bill**, which increased to **8.84% (+0.63% m/m)**. The **91-day Treasury bill** followed, rising to **8.83% (+0.44% m/m)**, while the **364-day Treasury bill** settled at **8.99% (+0.41% m/m)**.

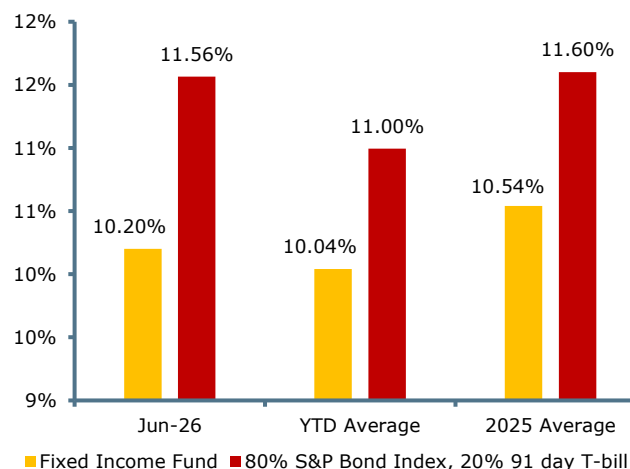
Fund Outlook

Fund performance may face pressure due to market-to-market losses as interest rates rise. However, this is partly offset by higher yields on new inflows. The fund offers investors with low liquidity needs an opportunity to lock in higher returns as assets are reinvested at prevailing rates.

Maturity Profile



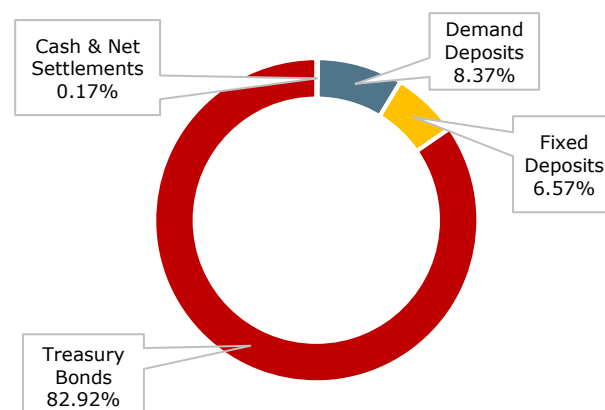
Periodic Returns



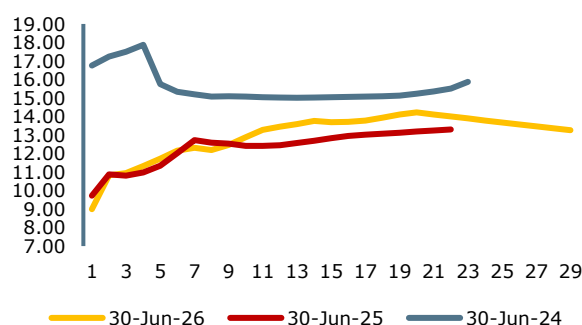
